2) MINUTES OF PREVIOUS MEETING

3) MATTERS ARISING

4) TREASURER'S REPORT

Balances are £9045.27 in the Charity Bank notice account and £2917.85 in the Community account. £0 in cash. Membership is 222; 291 including household members.

5) RATIFICATION OF CHURCH CONTRIBUTION

7) **NEWSLETTER**

10) PLANNING

a) Updates

Enforcements have been served on the van dump / vehicle storage at Cliveden Stud to be cleared up in 7 months from 02/09/2025.

b) New applications

2 at Cliveden Stud including retrospective application for a spray booth at Red Horse Centre. Hermitage applying for second house in grounds. Was stymied by large Wellingtonia tree in the way, which has suddenly died. Need to ask tree officer if it was a natural death.

c) Local Plan

No update. Lots of green belt likely to turn into grey belt. 95,000 houses are Bucks allocation.

- d) The barn by Buffins has got planning permission.
- e) Stonecrop (corner of Rectory Road) AF to check planning application against what is going up. Post Meeting Update (PMU): AF says "the thing I thought was a big single garage is actually a very imposing entrance hall!"
- f) Status of Ellington Road footpath between numbers 5 and 6, neither of which have been sold yet. Exceedingly narrow path. Rights of Way team on Council have taken it up. 3 months since latest update. Double fence could be reduced to one.
- g) No planning application exists on the Boundary Road allotments.
- h) £40K in parish budget from Bishop Centre + £12K from CIL.

11) TAPLOW NEW TOWN

Publication of Task Force document for new towns now likely to be December to announce 12 sites.

12) **AGM**
