4) TREASURER'S REPORT

6) PLANNING

Michael Barnes has joined Taplow Parish Council and has taken responsibility for Cliveden Stud planning applications (reported below). General planning seems rather quiet!

a) Updates

Having removed the problem of the large Wellingtonia tree in the way, which suddenly died, The Hermitage immediately applied for planning for a second house in the grounds. It was refused on the grounds of conservation area and flood plain.

Appeals still in progress at Skyfall.

b) New applications

No general new applications of interest.

c) Local Plan

RW & Martin Maund have worked through the Local Plan consultation documents and have made a set of suggested responses. The next consultation will be the formal one to approve the final plan. Dorney have taken a different approach and put in a total local defence of Dorney,

- using the approach taken for the Taplow New Town objection (lots based on flood risk). RW doesn't know if anyone takes any notice of these efforts.
- d) Status of Ellington Road footpath escalated within rights of way organisation. Area officer will write to owner telling them to rectify. Need to make sure Estate Agent knows there is a dispute as potential buyers probably shouldn't rely on responses from the seller.
- e) Hitcham House Farm (dairy / ice cream farm). JC & AF had a phone call (as HTS contact number) saying that the owner died and his son wants to realise significant cash. Moves to build on that farm. JC forwarded phone number and synopsis to RW.
